- 1.) Should any animal become ill or seem to be in need of medical attention, we reserve the right to administer aid and or use any available veterinarian. Any expenses incurred in obtaining such medical, including transportation costs, shall be the responsibility of the pet owner and are to be paid in full when pet is picked up.
- 2.) Daily boarding charges begin accruing on the date entered in this contract. Customer agrees to notify kennel if there is any change in the date animal(s) is to be picked up. No boarding animal will be released until all charges are paid in full.
- 3.) Seventy two hour notice is required for cancellations. Reservations for peak times and holidays must be confirmed and owner will be liable for full reservation fees in the event that the cancellations or changes are not received seventy two hours prior to drop off.
- 4.) Pet owner shall remain liable for the complete boarding bill, as well as other charges incurred in the care and maintenance of said animal(s) as listed on this contract. The owner further agrees to be solely responsible for any and all acts or behaviours of said pet while in the care of the kennel. The owner of the animal or his said agent agrees to pay reasonable attorney fees incurred by the kennel in the collections of any boarding, grooming, or other charges incurred by the owner of the animal or his agent.
- 5.) Pets arriving with fleas/ticks will be bathed/dipped at the owner's expense in order to maintain parasite control in the kennel.
- 6.) Dogs entering the kennel must be accompanied by proof of vaccination for the following: Rabies, Distemper, Parvo, and Bordetella.
- 7.) Cats entering the kennel must be accompanied by proof of vaccination for the following: Rabies, Distemper, and Feline Leukemia.
- 8.) The kennel is not responsible for collars, leashes, bedding, toys or other items brought into the kennel.
- 9.) It is expressly agreed by pet owner and kennel that kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200.00 per animal boarded.
- 10.) Pet owner agrees to indemnify and hold harmless Lucky Stars Country Kennels, LLC, its principals, agents, and employees, from any and all claims, demands, actions or liabilities for personal property damage or other loss of any party, which injury, damage or loss is caused by the actions of the clients animal(s).
- 11.) Charges start on the day of drop off regardless of the time of day. There is no boarding fee on the day of pick up.
